# Updates SEIU 925 by Melba Halgren

#### **Legislative Session**

We are now about half way through the current legislative session. It ends at the end of April. We still do not know if our 2015 - 2017 contract will be funded. If funded, providers would get another 2% subsidy raise. Republicans are opposed to funding our contract. "Stand Up for Education Campaign" is trying to get the top 1% to pay its fair share in taxes. The highest 1% earners only pay one-eighth the amount of taxes compared to the lower income people who pay 8X more in taxes (comparable to the income of both groups). Governor Jay Inslee is trying to fully fund education. His revenue package includes a capital gains tax (Washington is only one of 8 states who do not pay capital gains), a carbon tax on polluters, and closing the loopholes that allow big business to get huge tax breaks. The Early Start bill, if passed (in it's current form) would mandate that licensed providers must enroll in the Early Achievers program (administered by DEL) and score a level three or above in order to provide care for state- subsidized children through Working Connections. This would eliminate child care options for thousands of families. SEIU providers have sent thousands of emails in the last few

weeks demanding the mandate be removed. Some legislators are trying to take away nonstandard hours bonuses. If they succeed there would be 3,000 children affected and some providers could not be able to afford to do after hours care. These legislators are also trying to take away the cap on absent days and the 2% subsidy rate that we won in bargaining in our new contract (2015 - 2017).

The electronic time in – out attendance is not likely to get funded this legislative session.

#### Community

March 11<sup>th</sup> SEIU organized providers to show up to a Town Hall Meeting sponsored by Child Care Aware and facilitated by DEL. Providers came prepared to question DEL about how Family Child Care providers can participate in ECEAP. The union bargained and won the right for providers to apply as contractors for ECEAP slots and now we need to make it a real option for providers.

The Freedom Foundation along with a national anti-



worker committee is funding a law suit for four childcare providers to sue SEIU and the state of Washington. Theses providers are claiming they were forced into the union. Two of these providers willing ran and served in leadership positions in our chapter. This national committee has filed similar cases across the country as part of their strategy to eliminate workers' rights to have a union. The F.F. wants to weaken our union by persuading providers to abandon their union rights. Don't be misled if they contact you. They are trying to destroy all of our gains & hard work

our gains & hard work from the last 8 years, but we can protect all the gains we've fought so hard for and fight future attacks if we stay together as a union.

#### Member benefits.

SEIU Local 925 will be launching an exclusive member benefits program with a lot of great discounts for our members this spring. Stay tuned! There is now an attorney contracted with SEIU who specializes in Administrative Law. If a member is closed down and needs help, SEIU pays the first \$500 attorney's fees as a member benefit and the provider would get 50% off future services. contact the Member Resource center at 1.877.734.8673.

Printed copies of our new 2015-2017 contract will be available after the legislative session once it is funded and approved.

Members are now eligible to attend and get Merit training for **special trainings** throughout the state. Within the last month there was a tax training put on by Tom Copeland.
