Updates SEIU 925 by Melba Halgren

Dear Providers: Here are some important things to know.

Our new contract is up on the www.SEIU925.org website. It started July 1, 2015 and goes until June 30, 2016. Read it and see what we have won!

The next Regional meeting will be held at our union hall at 505 E 22nd St from 6:30 PM to 8:30 PM on October 14th. Two hour STARS for attending. Refreshments. There will be information on:

- Our new contract with higher rates
- The Members Benefits Program keeps expanding
- Early Achievers Bill and bonuses. Note: You must be signed up with Early Achievers by June 2016 and reach a Level 3 by December 2019 to get subsidized children in 2020.
- ECAP positions open to providers
- New Professional Training Institute created
- Needs Based Grants of \$500 to help get to Early Achievers Level 3
- Enhanced Subsidy rates and awards for FFN and Licensed Providers
- New Substitute Pool with Merit-approved substitutes

Providers: I love our union! It was the Washington State Family Child Care Association that sought out a good union to represent childcare providers. They chose SEIU 925. Our union has won so much for us. I hope you all become members and help keep our union strong. Don't be misled by flyers coming in the mail telling you to Opt Out. 
The class will begin at 9 AM and end at approximately 1 PM. This training will be valid for 2 years at a cost of \$45.00.
